

**MONTGOMERY COUNTY BOARD OF EDUCATION
BUDGET WORK SESSION**

April 2, 2012

The Montgomery County Board of Education convened in a work session on Monday, April 2, 2012, at 4:30 p.m. prior to the regular board meeting with the following members present:

Chairman DeBerry called the meeting to order.

Superintendent Ellis reported that the committee set up to study the budget and possible changes that need to be made in conjunction with such has been diligently working on those recommendations. The group went over closely the lists for local expenses to see what everything was for. We are requesting \$5,000,000 which is slightly more than we received last year, but well below the \$6,228,055 received in 2008-2009. We are requesting a one-time capital outlay expenditure of \$270,000, which will allow us to make a million dollar upgrade in our technology network infrastructure. The \$3.2 million we are applying for in the QSCB grants to be paid for by the ¼ cent sales tax, will be making capital improvements of over \$4 million with only \$270,000 burden for the county. We are currently facing a \$1.4 million cut from the state for 2012-2013 year.

Kathy Johnson gave an overview of our budget situation from a local and state perspective. She also showed current local budget and projected local revenues.

These estimates are based upon information received from the Department of Public Instruction's initial allotment and the Governor's proposed budget indicating reduction areas for 2012-2013. The information currently provided is subject to change when actual state budget is adopted.

MINUTES

April 2, 2012

The Montgomery County Board of Education convened in its regular monthly meeting on Monday, April 2, 2012, at 6:30 p.m. Board members were present as follows:

Chairman DeBerry called the meeting to order and asked for a motion to approve the agenda as shown with the change to approve the consent agenda after the closed session. With a motion from Bryan Dozier, and a second from Shirley Threadgill, the agenda was adopted with unanimous approval from the board with this change.

Opening remarks by Chairman DeBerry were from Matthew 6:34. Don't be anxious for tomorrow for it has its own trouble, keep something for the now. Stay focused on the here and now and the future will take care of itself.

The Pledge of Allegiance to the Flag of the United States of America was led by West Montgomery High Schools Students, Breasha Little, 12th Grade and Zachary Davis, 11th Grade.

With no one signing up to address the board, the meeting continued on to the recognition portion of the meeting.

The Community Partnership Award went to West Montgomery High School Supporter, Parent, Volunteer Coach of Varsity Baseball Team, Graduate of West Montgomery High School, Mike Elkins. Mike leads a group of fathers to support whatever is needed at West Montgomery High School. They cut grass, kill weeds, and make things happen. Montgomery County Schools thanks you for your commitment and support.

The agenda continued to the presentation from West Montgomery High School. Principal, Jack Cagle presented students from their nursing program. Students can come out of this program with their CNA certificate which gives them the ability to work in the health care area immediately and to start their path of obtaining their nursing degree with these college level classes. This program gives them a head start with their career goals and also teaches them good character and professionalism.

Superintendent Ellis spoke about the North Carolina discretionary reversion that the state has continued to use for 10 years. State funds are given and then asked for them back. That has reached 1.4 million dollars. A resolution from Montgomery County Board of Education has been done to ask that this practice stop. We have to do what is right for the kids. The amount asked for continues to grow. With a motion from Bryan Dozier along with a second from Sandra Miller, the board unanimously approved this resolution. It will be sent to Montgomery County's Legislative representatives and the North Carolina School Board Association.

Superintendent Ellis went on to discuss the payroll plan. With a motion from Sandra Miller and a second from Ann Long, the board unanimously approved this plan to offer 10 month

employees a 10 month pay option, a bank sponsored "Summer Cash" option, and a 12 pay installment option, assuming such an installment option is possible in 2012-2013 and years beyond.

Superintendent Ellis then presented information about the addition of driver education fees. We are breaking even at this point, but with further cuts it needs further revenue to be viable. Other counties in this region have been charging for this program already. This will be put in the form of a policy change which will be effective beginning the 2012-2013 school year after it is approved at the May 2012 meeting.

Superintendent Ellis asked for approval of the policies and regulations that had been presented at the March 2012 meeting. With a motion from Ann Long, along with a second from Shirley Threadgill, the board unanimously approved them. They were as follows.
