Enclosed is a deployment plan and outline for the Joint Facilities Task Force. The Task Force will look at long term needs of the school system. Commissioners Dolan Corbett and Jim Matheny will serve on the Task Force representing the County Commissioners.

What: Joint Facilities Task Force

Who: 2-3 members of the Board of Commissioners

Process: The Joint Facilities Task Force will meet to review the various facilities needs

of the Montgomery County Schools. The group will tour facilities within the school system. The Task Force will also tour construction and other facility projects completed in other school districts. The task force will develop a prioritized facilities plan to address the long-term capital facility needs of the school system. The Task Force will also explore possible funding options to make recommendations as applicable when funding for such projects becomes

available.

When: September 2011 and ongoing until final Adequate Facilities Plan is

developed and approved

Why: The current capital facilities needs for the school system are great. The last

long range facilities plan called for almost \$130m in capital improvements. While this wish list sounds great on the surface, the system realizes that the likelihood of such a plan being funded is remote given the current economic

conditions in the County. It is also assumed that even in an improved economy, the burden of such a facilities upgrade will not be feasible. But, the

need for critical improvements is still there. That is the purpose of this committee. The Joint Facilities Task Force will identify the most essential projects, those that have the greatest potential and need for funding so that a feasible long range plan can be developed. While it is understood that \$130m in capital funding is not a possibility, \$0 in capital spending cannot continue and the system be able to maintain what has already been invested in our

school buildings. The purpose of the Task Force is to provide a plan that will address the capital needs of the system over the foreseeable future, which will

be defined as the next 10-20 years.
