April 9, 2018

The Montgomery County Board of Education convened in a budget work session on Monday, April 9, 2017, at 5:00 p.m., prior to the regular board meeting with the following members present:

Steven S. DeBerry, Chair Tommy Blake, Vice Chair Jesse Hill Ann S. Long Sandra Miller Shirley M. Threadgill Bryan Dozier - Absent

Chairman DeBerry called the meeting to order and asked for a motion to approve the agenda as shown. The agenda was approved with a motion by Sandra Miller and a second by Tommy Blake.

Mitch Taylor gave an overview of our 2018-19 budget projections from a local and state perspective. He also showed current local budget and projected local revenues.

The state and federal budget estimates are based upon information received from the Department of Public Instruction's initial allotment and the Governor's proposed budget indicating reduction areas for 2018-2019. The information currently provided is subject to change when the actual state budget is adopted.

MONTGOMERY COUNTY BOARD OF EDUCATION MINUTES

April 9, 2018

The Montgomery County Board of Education convened in its regular monthly meeting on Monday, April 9, 2018 at 6:30 p.m. Board members present were Steven W. DeBerry – Chair, Tommy Blake – Vice Chair, Jesse Hill, Ann Long, Tommy Blake, Sandra Miller and Shirley Threadgill. Bryan Dozier was absent.

Chairman DeBerry called the meeting to order and moved to adopt the agenda as shown. Sandra Miller made the motion with Jesse Hill seconding. The agenda was accepted with unanimous approval from the board.

Chairman DeBerry opened by reading a devotional reminding us that when you point a finger at others, there are three pointed at you. Much is gained by earnest self-examination; see yourself as you are and improve upon it.

Star Elementary students Wesley Auman and Patricia Santibanez-Alvarez led the Pledge of Allegiance to the Flag of the United States of America.

No one signed up to address the board during the public comment period.

Superintendent Ellis and Principal Jennifer Beck recognized Star Elementary Certified Employee of the Month Amanda Henley and Classified Employee of the Month, Karen Blake. Mrs. Beck called both employees "leaders" and "an inspiration to others".

Dr. Ellis and Deidra Steed awarded a 2018 Governor's school certificate to Abigail Hamilton, a junior at East Montgomery.

Superintendent Ellis and East Montgomery Interim Principal Anne McLean recognized the 2018 NC Destination Imagination Competition winners.
