# MONTGOMERY COUNTY BOARD OF EDUCATION MINUTES

## **November 4, 2019**

The Montgomery County Board of Education convened in its regular monthly meeting on Monday, November 4, 2019 at 6:30 pm at Montgomery County Schools Central Office. Board members present were Steve DeBerry – Chair, Tommy Blake – Vice Chair, Jesse Hill, Shirley Threadgill, Bryan Dozier, and Trikena Simmons. Sandra Miller was absent.

Chair Steve DeBerry called the meeting to order and moved to adopt the agenda as shown. Bryan Dozier made the motion with Shirley Threadgill seconding. The agenda was accepted with unanimous approval from the board.

#### Fiscal Year 2019/2020 Budget Amendment # 1

#### State Funds

#### 1) A net increase of \$283,324.00 to the State Budget Fund (Fund 1):

Agenda Item (Section - Consent Agenda)

\$200,000.00 increase in PRC 055 (Cooperative and Innovative High Schools) – The state provides this allotment to offset the expenses of having an early college high school.

\$2000.00 increase to PRC 056 (Transportation) – The State provides funding to pay the NC DMV fees for tags, title and tax related to the new school bus received by the district.

\$44,836.00 increase to PRC 067 (Asst. Principal Interns) — This funding is to reimburse a portion of the salary expense for the district's assistant principal intern currently enrolled in the PPEERS program at UNC-G.

\$344.00 increase to PRC 015 (Technology) – This funding represents our district's portion of the interest earned by the state on their technology fund account.

\$2788.00 increase to PRC 003 (Non-instructional Support Personnel) – This is to reimburse the district for substitute expenses incurred while our non-instructional staff attended state required training during the months of May, June and July.

\$33,356.00 increase to PRC 073 (School Connectivity) - This represents the district's telecommunication projects that have been approved to be paid through E-Rate funding.

# 6) An increase of \$1,506,112.13 to the Special Local Fund (Fund 8)

\$750,000 increase to PRC 379 (School Climate Transformation Grant – RESTORE Grant). This is a federal grant jointly awarded to our district and Stanly County Schools to promote mental and emotional health in our districts. Monigomery County Schools is the fiscal agent for the grant.

\$749,960.00 increase to PRC 377 (Literacy Grant) - This is the Year 2 funding of a federal grant awarded to our district to promote literacy in our county by increasing access to books, expanding our reading programs and took, along with keeping our media centers open beyond normal hours.

\$1000.00 increase to PRC 617 (Donation for Music Teachers) – This was a donation from the Association of Retired Teachers in Montgomery County for the purpose of providing additional supplies and materials funding for our music teachers.

\$5152.13 increase to PRC 377 (Literacy Grant) — This represents funding left over from Year 1 of the Literacy Grant that is available to be used in year 2.

# 4) School Improvement Plans

Dr. Maxine Brown, Principal of Troy Elementary presented "External Development Leadership." During this PowerPoint presentation she discussed programs in place at Troy Elementary that result in community engagement, support and ownership. Their programs invite the community, parents, students and faculty to "Be Our Guest." They have hosted Spring Carnival, STEM Night, Math Night, Literacy Night, Grandparents' Day, and Real Men Read. The Christmas Caroling event continues to grow. Year one included

122 sign up. Year two increased to 188 signing up. A Beautiful You Inside and Out partners with MCC, local businesses and churches to build self-esteem, positive body image and education. Young Men of Honor partners with Boy Scouts, One Stop Barber Academy, Red Cross, and Troy Police Department. Despite the popularity of charter schools Troy Elementary has grown enrollment in 2016-2017 with 241 students to 313 students in 2019-2020. Academically TES students were at 50% on grade level on their Beginning of 3<sup>rd</sup> Grade Test.

Dr. Ellis recommended to the board that we move forward partnering with ESS. The board discussed the potential savings of retirement costs will cover the costs of service. February 1, 2020 will be the start date. Substitutes, teacher assistants, bus drivers and custodians will be hired by ESS. Current employees will be given the option of staying with MCS or moving to ESS. Bryan Dozier made the motion to approve Trikena Simmons seconded. The board unanimously approved.

Gina Smith and Sharon Harrell presented a power point on visits to the First Health School Clinics. The clinic had 5,073 visits in 2018-19. There were 957 flu vaccines given, 433 sports physicals and 1,466 dental visits. The clinic's mission is to continue to provide high quality, compassionate and appropriate services to students and staff, while increasing efforts on mental health issues and to pursue funding opportunities for sustainability and expansion. Mrs. Smith thanked the administration and board for their ongoing support. Regina Smith will be retiring this year with CJ Haywood filling her position.

Vance Thomas updated the board for SHAC (Student Health Advisory Committee). This committee consists of individuals selected primarily from the health and education segments of the community. The goal is to influence students to lead healthy and productive lives through policy changes, education and exercise based programs. Their focus this year is to combat mental health issues, vaping and e-cigarettes.

Dr. Lancaster presented Policy 3101 Dual Enrollment for approval. Tommy Blake made a motion to approve and Jesse Hill seconded. The board unanimously approved.

Dr. Lancaster presented the following policies for first read: Policy 1310/4002 – Parent Involvement, Policy 2010 – Board and Superintendent Relations, Policy 2300 – Board Meetings, Policy 3228/7323 – Use of Personal Technology to Conduct School Business, Policy 3620 – Extracurricular Activities and Student Organizations, Policy 4040/7310 – Staff-Student Relations, Policy 4325 – Drugs and Alcohol, Policy 4333 – Weapons, Bomb Threats, Terrorist Threats and Clear Threats to Safety, Policy 4334/5035/7345 – Use of Unmanned Aircraft (Drones), Policy 4400 – Attendance, Policy 4700 – Student Records, Policy 5015 – School Volunteers, Policy 5070/7350 – Public Records-Retention, Release, and Disposition, Policy 5071/7351 – Electronically Stored Information Retention, Policy 5210 – Distribution and Display of Non-School Material, Policy 6125 – Administering Medicines to Students, Policy 6305 – Safety and Student Transportation Services, Policy 6420 – Contracts with the Board, Policy 7100 – Recruitment and Selection of Personnel, Policy 7130 – Licensure, Policy 7240 – Drug-Free and Alcohol-Free Workplace, Policy 7241 – Drug and Alcohol Testing of Commercial Motor Vehicle Operations, Policy 7360/8225 – Crowdfunding on Behalf of the School System, and Policy 7410 – Teacher Contracts. These policies will be up for approval at the December board meeting.

Superintendent Ellis presented an update on construction at the site. A PowerPoint presentation was shown with progress being made throughout the campus. Overall it is starting to look more complete. CTE substantial completion date is now November 22, 2019. MCHS substantial completion date is now March 23, 2020. The second semester start date for CTE students is January 23, 2020. Next meeting date is November 7, 2019.

During *Superintendent's Remarks*, Dr. Ellis presented "What is Impacting Student Learning" from the Student Council Advisory Committee meeting held October 23, 2019. Concerns and positive thoughts were discussed among our middle school and high school representatives. Dr. Ellis was unable to attend this meeting and will follow up at next meeting.
