Attached you will find a budget amendment for your consideration for the year ending June 30, 2019.

#### Fiscal Year 2018/2019 Budget Amendment # 5

#### **State Funds**

#### 1) A net increase of \$41,869.00 to the State Budget Fund (Fund 1):

\$38,156.00 increase in PRC 063 – This is an additional allotment of EC funding that we use to pay our two speech therapists that work with our EC students.

\$3375.00 increase in PRC 003 – Funding to reimburse the district for hiring substitute teachers while our teachers attend professional development.

\$338.00 increase in PRC 015 – On a quarterly basis, all school districts are given a portion of the Indian gaming funds earned by the state.

\$177,386.00 shifted from PRC 013 to PRC 014 – Shifting surplus funds from the CTE budget that salaries are paid from to the CTE budget from which programming expenses are paid. The net effect is that the CTE salary budget is decreasing and the CTE programming budget is increasing by a like amount.

\$115,537 shifted between the textbook budgets PRC 130 to PRC 131 – PRC 130 is the budget containing our textbook funds, but the funds have to be transferred to PRC 131 in order to purchase textbooks and digital supplies. The net effect is that the allotment textbook budget is decreasing and the textbook purchasing budget is increasing by a like amount.

#### 3) A net increase of \$1532.37 to the Federal Budget Fund (Fund 3):

At the beginning of the new school year, the state provides an estimate of the amount of funding we are to receive for each federal program. By October and November the state disperses the actual funding to the district. Sometimes the amounts are slightly different than the original estimated amount. This increase of \$1532.37 is comprised of adjustments to the budgets for PRC 049, PRC 103, PRC 104, PRC 108 and PRC 111 representing the difference between the initial planning estimate and the amount of funding actually received.

#### 6) An increase of \$1000 to the Special Local Fund (Fund 8)

A local organization donated \$500 to each of the district's two art teachers for the purpose of purchasing art supplies.

# 7) Overall, these adjustments resulted in an increase of \$44,401.37 to the total 2018/2019 budget for Montgomery County Schools.
